## Client Work

Laurel's real estate experience includes:

- Representation of commercial landlord in dispute with tenant over nonpayment of rent. Obtained a \$500,000+ judgment after an evidentiary hearing.
- Representation of tenant business in suit against landlord seeking enforcement of lease and covenant to repair following a fire. Obtained six-figure settlement for client pre-trial.
- Representation of REIT in claims against an engineering firm for breach of contract and professional negligence. Conducted research, drafted pleadings and motions, took depositions, conducted discovery, and worked with engineering expert.
- Representation of private property owner in matter involving adverse possession and easement claims against adjacent property owner. Drafted all pleadings and motions and successfully settled dispute pre-trial.
- Representation of landlord in suit against commercial tenant. Obtained non-redeemable judgment for possession and monetary damages.

Laurel's construction experience includes:

- Serving on trial team that successfully represented project owner in complex construction matter involving allegations of deficient work and schedule delay. Responsible for drafting all pleadings

and briefs, taking depositions, preparing expert witnesses, arguing motions, and identifying more than 1,000 potential trial exhibits. Team successfully defended against all claims and obtained a \$2.5 million+ judgment on cross-claims, which was reaffirmed on appeal.

- On behalf of project owner, supervised large-scale document review with 10+ reviewers, involving architectural plans, requisitions, submittals, change orders, commissioning reports, etc.
- Assisted structural steel fabricator in reaching settlement at mediation with subcontractor in complex dispute involving construction of a bridge.
- Worked with project owner to obtain release of multiple mechanic's liens encumbering the property, as well as dismissal of various litigations involving the project.
- Drafted COVID-19 construction remobilization plans and demand letters related to issues such as unpaid change orders, recovery schedules and delays, and mechanic's liens for various general contractors and subcontractors.

Some of Laurel's other recent experience includes:

- Researched and drafted expert report opining as to whether two Coblenz agreements reached between bankruptcy trustee and former officers of bankrupt corporation were enforceable against policies.
- Representation of metals trader and investor in arbitration matter with commercial buyer over unpaid invoices. Successfully settled claims pre-arbitration for full seven-figure amount in dispute.
- Successful defenses of large technology company in multiple small claims matters.
- Representation of health care provider in audit of Medicare claims. Reviewed thousands of patient insurance verifications, conducted legal research, worked directly with client and auditor, and developed strategy for reducing provider's overall liability by close to \$1 million.
- Assisted in recovery of more than \$1 million in underpaid managed care claims on behalf of health care provider.
